LOUISVILLE PARANORMAL INVESTIGATIONS - DERBY CITY HAS A WINNER IN A DIFFERENT SPORT

We can't deny that there are hundreds of paranormal investigators nowadays. This once ridiculed belief system and curiosity is now nearly as interesting to people as the benefits of coffee. In my interviews, experiences with groups, and personal observations I have not met many who have as much variety of unexplained encounters caught on audio or video. One such team is Henry's group, Louisville Paranormal Investigations.

LPI has a documentary series with some pretty astounding footage that covers different haunted locations in Kentucky. Titled "Shadows of Kentucky" this series is full of communication with the dead via Ghostbox, apparitions, orbs, chairs being knocked over, etc. It spans places like the Brown Theater, Middle Creek Battlefield and the eerily mysterious Baxter Avenue Morgue. Their website, LouisvilleParanormalInvestigations.com is designed to be easily navigable with footage, pictures, evp recordings and so much more. They have one of the more impressive and easy-to-navigate websites concerning paranormal that I have found and I'm all about easy, like instant pudding or wearing socks to bed so I don't have to put them on when I wake up in the morning. Just kidding.

So how does the dynamic duo of founders Henry and Carolyn get all this amazing stuff and keep a day job? Let's find out.

Daniel/AR: It's clear that you know what you're doing. It's also clear that you have done a lot. To start off with what do you all do currently as a day job since you don't charge to investigate?

Henry and Carolyn/LPI: (Henry) I work in Securities. (Carolyn) Unemployed.

Daniel/AR: What was it that made you decide to study and seek evidence of spirit life?

Henry and Carolyn/LPI: The desire to find what is after we pass. Is there something beyond what we know, and what happens to us after this life? It is ignorant of us to think that this is all there is. What happens to our being after our body dies? Can we communicate with the living after we are gone. Are there choices that can be made when we die or is it determined what will happen to us? These are just a few of those questions we are trying to answer.

Daniel/AR: You were a huge skeptic and, if I understand correctly, it took a number of instances before you finally declared yourself a believer. Tell us a few things that led up to this change.

Henry and Carolyn/LPI: My dream catcher began banging on the wall in my home, just like the way my dad used to knock before he died. The feeling that someone was getting in bed with me. That went on for a few months before I set down rules and told whatever was doing it had to stop or else I was going to make it leave. It hasn't happened since that night. My ice maker on my fridge used to click on by itself. After buying a new fridge it continued to happen. But what topped it off was a

private residence where we captured what appears to be 3 entities in a closet. That did it for me.

Daniel/AR: Without having to kill me, what can you tell us about your job with the government?

Henry and Carolyn/LPI: Well like you said....

Daniel/GS: How factual do you think the Men In Black movies were?

Henry and Carolyn/LPI: Are you kidding? FACTUAL! Who else can kick an aliens butt and still not sweat?

Daniel/AR: Do you think Will Smith or Tommy Lee Jones would look better in white?

Henry and Carolyn/LPI: No.

Daniel/AR: Please inform us a bit of how your team got together.

Henry and Carolyn/LPI: It started out with just Carolyn & I. We have on our site new members welcome and people began to ask to join. So far to date every person who has taken our classes have joined LPI. It makes for a very well trained team. Everyone investigates the same way.

Daniel/AR: If I recall correctly, you told me that the current owners of Baxter Avenue Morgue was originally going to have TAPS investigate. However, your collected evidence and reputation of not being phony in any way got you picked to do it which is now an ongoing investigation. Will you elaborate on that please or correct the story as I understand it?

Henry and Carolyn/LPI: We did our first investigation, gave the evidence to the events director Jamie, he was very impressed with our findings, he asked us to do a followup. After that investigation we captured more evidence that we could not explain. He then asked us to continue to investigate the morgue. Now we hold paranormal classes, overnight investigation all at the morgue.

Daniel/AR: I am a huge fan of acronyms such as TAPS and LPI. As fast as possible come up with alternate meanings for each. I'll go first;
TAPS: Today A Person Screamed
LPI: Little People are Interesting
Your turn!

Henry and Carolyn/LPI: TAPS; The Almighty Paranoid Screamers -
LPI: Level-headed People's Intuition.

Daniel/AR: Your documentary series is amazing. After meeting you and Carolyn it seems that you have a humble compassion and in some ways I believe that it makes a difference. Are there any new ideas or theories you have about spirits that you think no one else has? If so, how have you tested these ideas or theories?

Henry and Carolyn/LPI: I am sure everyone has similar theories regarding the afterlife. What makes us different is that we will not address a spirit as if they have crossed. We speak to them with respect, and in the present tense. Never ask when or how did you die. There are things that we might do differently but those are LPI's ideas. We have come up with some new equipment, ways to use the old tried and true equipment. Different lighting. To name a few.

Daniel/AR: I am going to give you a list of things that I want to know if you have seen or experienced during any investigations.

Babies crying?: yes

Being touched by an unseen person?: yes on numerous investigations

The Great Pumpkin?: No sorry that was Charlie Brown

Santa Claus?: Shhhhhhhh my grand-kids think we have.

Apparitions?: Yes

Body parts that move and disappear?: Yes

Poltergeists?: Yes

Missing socks?: Check your dryer.

Elvis?: He went home.

Any type of UFO?: No

Conversations with a spirit?: Yes through the Ghost Box.

Daniel/AR: You hold classes at the Baxter Avenue Morgue regularly. Give us a rundown of what one can expect from a course.

Henry and Carolyn/LPI: We teach to investigate the way LPI investigates. We go over common terminology used, equipment, and how to use it. How to contact the client and give the client your findings. We also do a road trip investigation. After which the class has to present myself and Carolyn with their findings as if we were the client. We also investigate Baxter Avenue Morgue to see how many will run when scared.

Daniel/AR: Does your class offer any certifications?

Henry and Carolyn/LPI: No, there is no such thing as a certification in the paranormal. We give an award for completion of our course.

Daniel/AR: Do any of you have credentials related to paranormal investigation?

Henry and Carolyn/LPI: No there are not any. Those who say there are, are incorrect. Our question is this; who gave them their credentials? This is an ongoing learning field. There are no, and will never, be any experts. You may be an electrical engineer, or a physicist, but we are not.

Daniel/AR: Please tell us all the cool places we can go to see or read more about your stuff.

Henry and Carolyn/LPI: The best place would be www.louisvilleparanormalinvestigations.com our website. We keep it updated with current investigations, and we change out evidence routinely so all evidence can be viewed by the public. We feel that everyone should be able to view our public findings. If a business or homeowner request it, we will not post any thing. All evidence captured is the property of the business or homeowner. We thank them for the privilege to investigate.

Daniel/AR: Is there anything else you would like to include that we didn't cover?

Henry and Carolyn/LPI: We started Shadows of Kentucky in 2009, we have now began Shadows Across America. This is a continuation that includes all the States. We have began taping those now, and have some great investigation locations.

Daniel/GS: Final question, it's a doozy. If you had a choice to experience an unexplained phenomenon which would you choose, how would you try to communicate with the living if you had crossed over and which actor do you think could most accurately convey your experience?

Henry and Carolyn/LPI: Nothing. I already have. By coming across in any way possible. Not sure who would be the actor.
